AATZ is an affiliate member of the Action Aid International Federation that is working in over 45 countries worldwide committed to achieve social justice, gender equality and eradication of poverty.

AATZ is known for its deep-rooted interventions that empower people living in poverty and exclusion and works in partnership with Community Based Organizations, Non-Governmental organizations, and other stakeholders at local and National levels to tackle the root causes of poverty, injustice, and hold decision makers to account for the realization of the needs and rights of people. Its grass roots programs are primarily implemented directly with communities, their organizations, and local partners while at the national level, AATZ works in networks, coalitions, forums, and in partnership with like-minded national and international organizations.

- The Minimum Requirement/Selection Criteria will include:

#### Legal competence

- >> Submission of all registration certificate from relevant authorities.
- >> Valid business license.
- >> Company certificate of incorporation; or extract from the registrar
- >> TIN & VAT Registration (for registered)
- >> Tax clearance certificate of the latest year.
- >> Company memorandum and article of association.
- >> Registration from relevant professional boards for Companies and Experts (if any)
- >> Proof/Certificate of manufacturer dealership/Agent with reputable goods/service (if any)
- Current physical location (which will be inspected for verification); that is a valid right of occupancy of office premises or lease contract;
- >> Current annual returns updated in the BRELA online registration system/ORS detailed company search report and
- >> Submission of Power of Attorney Document.

#### Capabilities Competence and eligibility:

- » Submission of Three years audited financial statements (i.e. 2020, 2021 and 2022); or
- At least 1 reference from the applicant's bankers regarding supplier's credit position; All bank statements of the suppliers' active bank accounts for the past 6 months; and a guarantee from any reputable bank/financial institution to support any declared alternatives source of funds The company/experts must have not less than two (02) years' experience in the relevant field; The company must have experience in similar nature of business and complexity in different organizations; submission the list of key staff with their CVs demonstrating their ability to carry out the applied service; At least 3 names, address and contact of the applicant's clients, value and duration of the contracts (submit copies of contracts/acceptance or completion certificate as proof) entered with the clients in the past three years; and Submission of at least 3 recommendation letters from different clients
- >> Submission of certified declaration on Litigation information regarding your firm
